MESSAGE

FROM CHIEF EXECUTIVE OFFICER



Dear Friends & Supporters of Chinese Hospital,

This year marks Chinese Hospital's 123rd year serving the people of Chinatown and the San Francisco Bay Area. Our history is rich in both medical milestones and achievements, and as a landmark institution at the forefront of racial inclusion and cultural competency. As I reflect on the past years in relation to our 100+ years prior, a common theme emerges – Chinese Hospital is the Community's Hospital.

As you likely know, Chinese Hospital was born from necessity in the late 1800s. Facing systematic exclusion from other hospitals, targeted racism, hate-fueled propaganda, and violence, the Tung Wah Dispensary was founded because of a steadfast commitment to care for San Francisco's Chinese people. Today, many of our patients – from varying races and ethnic backgrounds – choose Chinese Hospital because of our commitment to delivering culturally competent, exceptional healthcare.

Another reflection I find particularly striking is the parallel relationship between Chinese Hospital's role in navigating COVID-19 and its response to the bubonic plague more than 100 years ago. In both public health crises, the reactions of the public at large and that of Chinese Hospital were the same. Public panic transformed to fear, then led to misinformation and misdirected blame, discrimination, and targeted violence. Undeterred in the face of such adversity during both the plague and COVID-19, Chinese Hospital provided widespread, community-focused public healthcare. In both cases, Chinese Hospital prevented an outbreak of disease in Chinatown and safeguarded the neighborhood, and subsequently San Francisco. During widespread public health emergencies in the past, present, and the future, our hospital is the community's hospital.

As I reflect on our past, it's equally important to plan for tomorrow. Chinese Hospital is the only remaining independent community hospital in San Francisco and the only of its kind in the country. Though our history stems from exclusion, we know that our future depends on collaborating and partnering with local healthcare institutions. San Francisco is home to many of the finest, groundbreaking, and well-regarded hospitals in the world. While we do not have the resources, capacity, or personnel to provide the same depth, breadth, and highly specialized level of treatment as hospitals like UCSF or Zuckerberg San Francisco General Hospital (ZSFGH), we do provide personalized, culturally attuned patient care that can only be found at Chinese Hospital.

Recognizing our limitations while maximizing our strengths, we are growing partnerships that blend our unique philosophy with our much larger neighbors' expertise and access to resources. To name a few of the collaborative cross-hospital relationships we are building:

- The Joint Commission Certified Primary Stroke Center in collaboration with UCSF
- Skilled Nursing Facility / Subacute Care Unit in collaboration with ZSFGH and San Francisco Department of Public Health
- Eye surgeries in collaboration with ZSFGH and UCSF

In order for Chinese Hospital to survive and thrive for generations to come, we know we can't do it alone and that partnerships like these are essential.

Looking to the future, I am excited to share that this year we received a \$7 million gift from the Charles Huang Foundation, the largest philanthropic contribution in our 123 years. Additionally, California State Assemblymember Phil Ting advocated and helped secure \$5 million of the state's budget for Chinese Hospital, marking the first time in our history that we've received state funding. Collectively, these funds will be used towards renovating our Outpatient Building. Specifically, this project will add much-needed subacute beds to the San Francisco healthcare ecosystem. This generous monetary support shows that community members and government officials alike recognize Chinese Hospital's impact and importance locally and nationally.

This project is not a finish line, but rather the start of our next chapter. We will continue to work with our community physicians and other hospital partners to provide the much-needed quality of care to our community.

In closing, I am grateful for our community – our healthcare providers and staff, board members and management team, local and statewide partners, donors and supporters. Together, we will make our community healthy and happy.

I wish you and your family a happy holiday season and good health in 2023.

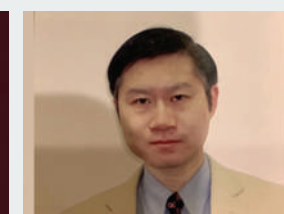

Amid the bubonic plague and COVID-19 pandemics, Chinese Hospital prevented an outbreak of disease in Chinatown, and subsequently San Francisco.

Throughout our history, our community has faced numerous scares of disease outbreaks, catastrophic natural disasters, and widespread public health emergencies. In each instance, Chinese Hospital has remained steadfast in its commitment to caring for the community.

Notably, there is a parallel relationship between Chinese Hospital’s roles in navigating COVID-19 and its response to the bubonic plague more than 100 years ago. During both pandemics, the circumstantial roadblocks and Chinese Hospital’s responses were the same.

Undeterred in the face of such adversity during both the plague and COVID-19, Chinese Hospital provided widespread, community-focused public healthcare open to all San Franciscans, regardless of race.

During widespread public health emergencies in the past, present, and future, Our hospital – the community’s hospital – cares for San Francisco.



CRISIS-INDUCED ROADBLOCKS:

CHINESE HOSPITAL’S RESPONSE:

News travel of a novel disease/virus quickly spread worldwide.

Widespread fear grips communities, cities, and the general public.

Chinese Hospital immediately focuses on safeguarding the community.

Fear leads to panic, misinformation, and anti-Asian propaganda.

Scientific and medical recommendations are implemented with fidelity.

Misdirected blame is attributed to Chinese people for the genesis and transmission of the disease.

Targeted outreach is provided to the most vulnerable community members – for instance, healthcare teams bring care to those living in single-room occupancy buildings and the elderly.

Hate-fueled rhetoric, media and political slur campaigns (e.g., the “China Virus”), and growing anti-Asian sentiment leads to racial violence, exclusion, and discrimination.

Partnerships are established with local authorities and healthcare institutions to prevent further disease transmission, safely care for the sick, and collaboratively protect the broader community.

SAFEGUARDING THE COMMUNITY THROUGHOUT THE COVID-19 PANDEMIC

PLANNING & PREPARATION:

January 2020:

- Developed a comprehensive COVID-19 Preparedness Plan
- Began crowdsourcing personal protective equipment (PPE)

February 2020:

- Collaborated with American & Chinese media to educate the public & provide COVID-19 guidance



MOBILIZATION & ACTIVATION:

March 2020:

- First patients with COVID-19 admitted to Chinese Hospital
- Shelter-in-Place order implemented
- Suspended elective procedures
- Submitted COVID-19 Management & Prevention Program proposal for Chinatown's single-room occupancy (SRO) buildings to San Francisco Department of Public Health (SFPDH)
- Awarded initial \$250,000 grant from the Stupski Foundation to set up mobile testing



April 2020:

- Elevated Emergency Department classification to 'Basic Services'
- Opened 2nd floor for inpatient services, supported by \$1 million gift from Keith Tsu & Carmelita Ko
- Began receiving patients from Zuckerberg San Francisco General Hospital & implemented other citywide partnership measures
- Chinese Hospital's COVID-19 response was featured in *The New York Times*



May - October 2020:

- Implemented SRO testing, tracking, and outreach program
- Recognized by the San Francisco Board of Supervisors for COVID-19 response
- Maintained low COVID-19 case rates in Chinatown – the second most densely populated neighborhood in the United States



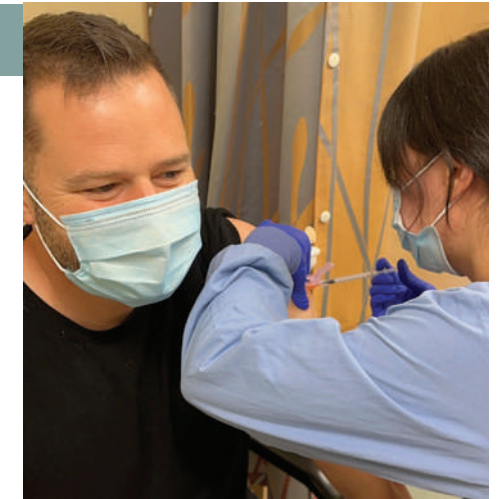
November & December 2020:

- Developed and implemented COVID-19 vaccination rollout plan

ON-GOING CARE:

January 2021 – present:

- Follow all guidelines from CDC and SFPDH
- Provide on-going testing, vaccination, and booster shot services
- Continue partnerships with UCSF, ZSFGH, and other healthcare organizations, including long-term future planning
- Community outreach efforts continue by
 - Providing home test kits to at-risk populations
 - Canvassing SRO buildings and administering vaccinations through door-to-door services
 - Distributing bilingual COVID-19 education materials



WIDESPREAD IMPACT: (As of 10/31/22)

Vaccinations:

- Administered over 56,000 vaccines

Testing:

- Performed over 40,000 tests at Chinese Hospital sites, SROs, and pop-up events
- Visited more than 30 SRO buildings with positive cases
- Distributed more than 210,000 rapid test kits

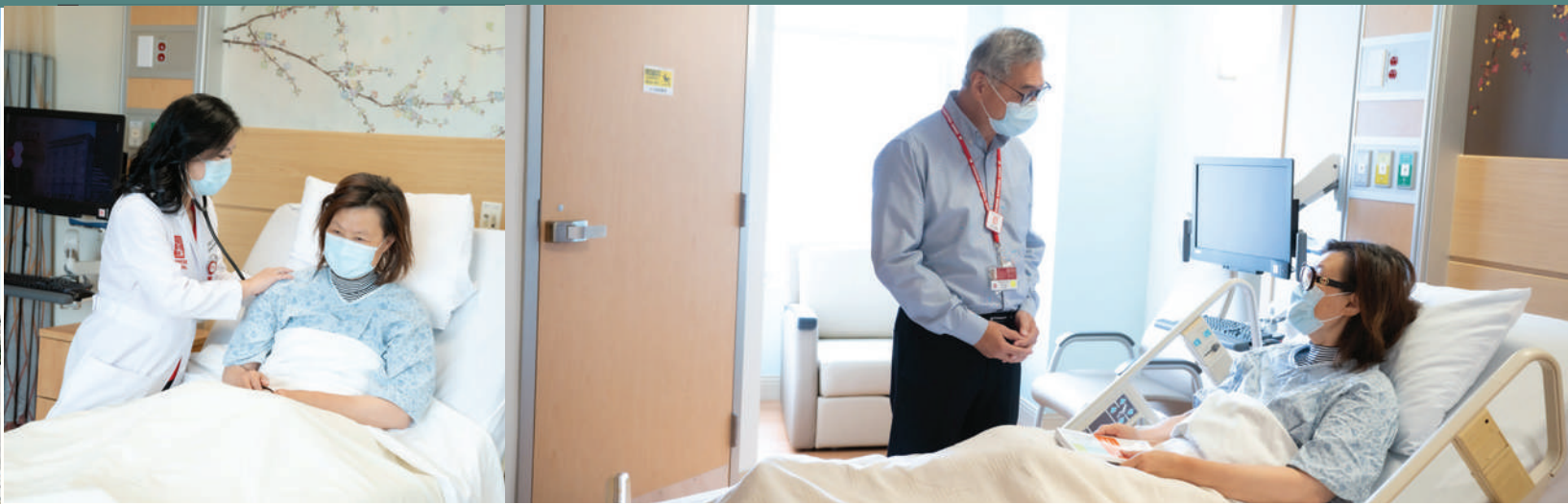

Chinese Hospital is ranked among the best hospitals in San Francisco, according to the Centers for Medicare and Medicaid Services (CMS).

Chinese Hospital is One of Two Top Hospitals in San Francisco

In CMS’s Overall Hospital Quality Star Rating released in July 2022, Chinese Hospital was awarded a four-star quality rating, which placed us in the top half of all hospitals ranked. CMS rated more than 4,000 hospitals across the nation, with only 890 receiving a four-star status. In comparing ratings of all San Francisco hospitals, Chinese Hospital was one of only two four-star hospitals, sharing that distinction with UCSF Medical Center, and none of the hospitals has earned a five-star.

About Overall Hospital Quality Star Rating

CMS developed the Overall Hospital Quality Star Rating system in 2016 to help consumers make more informed decisions about where to seek hospital-based care. The rating covers 47 different measures that impact mortality, the safety of care, readmission rates, the patient experience, and timely and effective care, and summarizes them into a single-star rating. The rating will show how individual hospitals perform compared to all hospitals across the nation; the more stars mean the better a hospital performed.

Why the Rating Matters

The rating allows patients to understand what’s important from a quality and patient safety standpoint and find confidence in the care they receive. The CMS rating offers solid reassurance that Chinese Hospital is worthy of the trust our patients and community place in us every day.

Ensuring patient safety and quality is at the core of everything we do. As we continue to intensify our commitment, we have implemented policies to help eliminate preventable errors, improve communication, and promote patient safety, as well as engage patients in their care. Chinese Hospital will continue to prove itself the leader in the healthcare industry and the best choice for San Franciscans seeking care in an increasingly competitive market.

PRIMARY STROKE CENTER

Recognized and Certified by The Joint Commission (TJC)



The new Primary Stroke Center at Chinese Hospital combines our culturally sensitive care with the world-class specialists and resources from the UCSF Comprehensive Stroke Center.

Goal of Partnership:

- Provide patients who are exhibiting stroke symptoms immediate treatment on-site by Chinese Hospital’s stroke team in collaboration with UCSF’s team of neurological specialists via telemedicine
- Decrease time between onset of symptoms, diagnosis, and treatment due to the proximity between Chinese Hospital and the majority of patients’ homes
- Increase the number of symptomatic patients seeking treatment because of the cultural familiarity, bilingual services, and comfortability of care at Chinese Hospital – most patients’ home hospital

Rationale:

- In the U.S.,
- Every 40 seconds, someone has a stroke
 - Every 3.5 minutes, someone dies of a stroke
 - More than 795,000 people suffer a stroke each year
 - Stroke is the fifth leading cause of death
 - About 87% of all strokes are ischemic strokes, in which blood flow to the brain is blocked
 - **TIME LOST IS BRAIN LOST.** Every minute a stroke goes untreated,
 - o Approximately 1.9 million neurons die
 - o Approximately 14 billion synapses are lost

In August, leaders from Chinese Hospital, CCHP and doctors from Chinese Community Health Care Association (CCHCA) pledged to work more closely together for the benefit of the community. The momentous gathering was to reaffirm their common mission of serving the community. In doing so, the entities reinforced their commitment to the integrated healthcare system in service of the community. The event also marked the resolution of disputes that arose in 2015 between the parties.

At the press conference to mark the event, Dr. Jian Zhang, Chinese Hospital CEO, noted “We are most pleased to make this announcement on CCHCA’s 40th year anniversary. This reaffirms our ongoing commitment to providing the most needed care for the community. We are strongest together as an integrated system.” “Further, I would like to thank Dr. Mai-Sie Chan, CCHCA Board President and the CCHCA leadership, for their dedication and commitment to finding a way forward.”

Chinese Hospital was founded by the community leaders to provide healthcare for the people in the community, the hospital has inspired numerous health organizations dedicated to serving the people. CCHCA is among the first of those organizations with Chinese Hospital at the center of care.

Dr. Zhang also announced that Chinese Hospital Association (CHA) will dedicate a floor of the

hospital in celebration of CCHCA’s founding in 1982. It will be an appropriate reminder of how important it is for the doctors and the hospital to work together for the best interest of our community.

Dr. Mai-Sie Chan said, “We are thankful to Chinese Hospital for this great honor. Forty years ago, the community physicians who had supported the Hospital throughout its history, organized into a nonprofit association, CCHCA, to better serve our community and provide culturally competent healthcare.” Adding, “This occasion marks the start of an era of even greater cooperation between independent doctors and the hospital to care for our community.”

“I’m proud to continue to serve the Hospital and our community. It is important that we continue to recruit community-minded physicians who will care for our next generation of patients. This is an auspicious moment, and we look forward to working more closely together.” – Dr. L. Eric Leung, past-President of CCHCA.

Mr. Kitman Chan, CHA Board Chair concluded by saying, “We couldn’t be more pleased with this cooperative commitment between the hospital and our doctors. Our hospital was founded on the promise of community’s health. The vitality of the two groups working hand-in-hand is the reason we remain the only independent hospital in San Francisco.”

Chinese Hospital Receives \$5 Million in State Funding to Create a Hospital-Based Subacute Care Unit

Access to subacute care is a state, regional, and national challenge. In San Francisco alone, there are zero hospital-based subacute care beds available to the public, yet the demand is increasing at an exponential rate.

Recognizing the urgent need within the community, Chinese Hospital has been working tirelessly with various government agencies and officials to improve the access to quality subacute care services in San Francisco. State Assembly Budget Chair Phil Ting (D-San Francisco) advocated for and secured a \$5 million state budget appropriation for Chinese Hospital to create a new subacute care unit as part of the larger project to completely renovate our Outpatient Building. This new unit will add thirty critically-needed subacute care beds, which will markedly decrease the overall need throughout San Francisco. The target completion date is in 2024.

Chinese Hospital is consistently named among the area's best hospitals and has an important role in safeguarding the community, particularly in times of public health crisis. As an essential part of San Francisco’s healthcare system, Chinese Hospital will continue to work closely with the city and state leaders and other healthcare systems like the San Francisco Department of Public Health and UCSF to help alleviate the burden on the local healthcare ecosystem and enhance the well-being of the greater San Francisco Bay Area.

Thank you, Assemblymember Phil Ting for partnering with and advocating for Chinese Hospital.

What is Subacute Care?

Patients in need of subacute inpatient care are being treated for post-acute illness, injury or disease, or complex health problems. The course of treatment includes a range of specialist services and supports such as post-surgical care, rehabilitation, intravenous antibiotic therapy, wound care, pain management, pulmonary and breathing care, and cardiac care.

The goal of subacute care is to improve patients’ functional status and overall quality of life. Hospital-based subacute units have a team of round-the-clock doctors, nurses, as well as other healthcare experts with specialized training to handle all emergencies.

Chinese Hospital CEO, Jian Zhang, was invited by SFCause to speak on issues among AANHPI regarding education, anti-Asian hate crimes, and health disparity. Both guests visited Chinese Hospital to have an in-depth discussion about the importance of community hospitals like Chinese Hospital and resources needed to ensure the sustainability of community hospitals. Also in attendance were Mr. Dennis Wu – C100 member, former San Francisco Mayor Willie L. Brown, Jr., Chinese Hospital board members and management team.



Follow-up Meeting at Washington D.C.

Dr. Jian Zhang, Chinese Hospital's CEO, conferred with Ms. Krystal Ka'ai, Executive Director of White House Initiative on Asian Americans, Native Hawaiians, and Pacific Islanders (WHIAANHPI), about issues affecting health and equity of Chinese and AANHPI communities in San Francisco and the Bay Area. Top on the agenda were: 1) Recognizing Chinese Hospital's efforts in advocacy, education, testing, and vaccination of the community; 2) Medicare's Disproportionate Share Hospital payment for community hospitals like Chinese Hospital; 3) Advancing equity, justice, and opportunity for AA and NHPI communities. Chinese Hospital will continue to work closely with the Initiative's national and regional offices for the community's benefit.

Central to Chinese Hospital's mission is our unwavering commitment to actively combatting anti-Asian discrimination, while simultaneously championing racial inclusion, modeling equity, and promoting education and awareness. This has been fundamental to Chinese Hospital since our founding in 1899.

As you know, our hospital was born from necessity. Chinese people faced blanket exclusion from accessing healthcare at San Francisco's hospitals in the late 1800s. Misappropriated blame was placed on Chinese people for spreading diseases like the bubonic plague and tuberculosis as well. Though society and perspectives have grown and evolved in many ways, racism, hate-fueled rhetoric, and misinformation are still present today. In the earlier stages of the COVID-19 pandemic, widespread panic gripped the community and once again Chinese people were wrongly blamed for the genesis and dissemination of disease. From politicians calling COVID-19 the "China Virus" to neighbors and community members targeting Asian people with violence and hate, the racism and discrimination the Asian community faced was both sweeping and pervasive.

Standing on the front lines of the COVID-19 public health crisis and the fight against Asian hate, Chinese Hospital was – and is – committed to caring for the community. Highlights of the actions we took include:

- Proactively educating the community about COVID-19, sharing research in multiple languages, and countering myths and rumors with science and facts;
- Co-hosting press conferences to condemn anti-Asian hate;
- Participating in the protest against anti-Asian hate;
- Working closely with the central police station to train our employees and community members on safety tips; and
- Co-hosting "Chinatown Night Out".

In recognition of our efforts to fight Asian hate and safeguard the community during the pandemic, Chinese Hospital received numerous commendations and certificates of appreciation from law enforcement agencies, local politicians, and other public services.

Though the volume and intensity of both COVID-19 and anti-Asian discrimination have diminished in recent months, the severity of each remains high. Chinese Hospital is dedicated to advocating, protecting, and caring for our community during public health crises and racial reckonings, and during periods of relative calm and peace. Chinese Hospital has been the community's hospital since 1899, and we promise to continue to be your advocate in public health and against anti-Asian hate.

This extraordinary philanthropic gift will help fund the redevelopment of Chinese Hospital's six-story outpatient tower. The refurbishment will touch every square foot of the building – the ultimate result being a state-of-the-art facility housing additional subacute inpatient beds, expanded services, and additional partnership programs to best meet the dynamic and growing needs of all San Franciscans.

SHELBY DECOSTA, UCSF HEALTH OUTSTANDING HEALTHCARE HERO

In the early months of the COVID-19 pandemic, Chinese Hospital was unable to obtain testing swabs, thus we couldn't administer COVID tests. Chinese Hospital CEO, Dr. Jian Zhang reached out to Chief Strategy Officer of UCSF Health and President of the UCSF Health affiliates network Ms. Decosta, and together they created a solution. Ms. Decosta mobilized her team to test patients from Chinese Hospital, and also provided the first 500 swabs for us to test the first single room occupancy residents. This began a partnership between Chinese Hospital and UCSF that spans multiple programs. With UCSF neurologists' consultations via telemedicine, Chinese Hospital was able to be certified by The Joint Commission as a Primary Stroke Center. This

means we can now accept patients exhibiting stroke symptoms at Chinese Hospital, provide world-class treatment in partnership with the neurology team at UCSF, and ensure the patient receives the culturally competent care that he/she is most familiar with. With a severe shortage of physician specialists, we will continue to expand our collaboration with UCSF across other disciplines. Ms. Decosta has been a true partner in health, helping us to ensure that all community members have access to and receive healthcare services. Chinese Hospital gave Ms. Decosta the 2022 Outstanding Healthcare Hero award at our 123rd Anniversary Celebration this spring.



ARTHUR CHAN OUTSTANDING COMMUNITY LEADER

Mr. Chan's philanthropy is widely recognized by the community. At Chinese Hospital, his support has helped fund our cancer program so that we are able to provide multidisciplinary care to cancer patients. This holistic model is the hallmark of Chinese Hospital's treatment – partnering culturally inclusive care with the highest standards and practices of modern medicine. Previously, Mr. Chan previously received the Jefferson Award for Public Service and the Spirit of Philanthropy Award in recognition of his

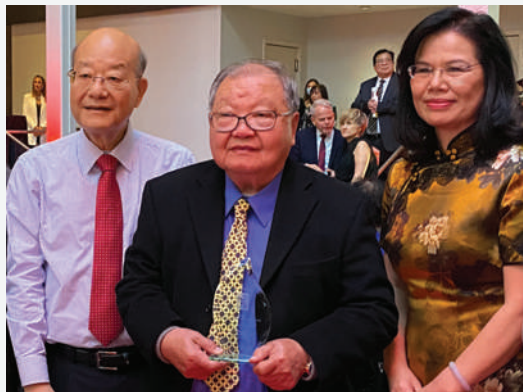
service to the community. Additionally, Mr. Chan's selfless generosity for Chinese Hospital totals nearly \$4 million. Mr. Chan's philanthropic support, passion, and dedication to building a community where the healthcare and wellness needs of all community members from all backgrounds are met is inspiring. At our 123rd Anniversary Celebration, Chinese Hospital gave Mr. Chan the 2022 Outstanding Community Leader award.



KEITH TSU OUTSTANDING COMMUNITY LEADER

At the beginning of the COVID-19 pandemic, Chinese Hospital experienced the frenzy common to hospitals nationwide regarding new healthcare guidelines, staffing shortages, scarcity of personal protective equipment and supplies, and maximum-capacity inpatient facilities. Understanding the need, Mr. Tsu helped fund key initiatives to meet these demands. Mr. Tsu's \$1 million gift enabled us to open our Inpatient Tower's second floor. These 23 inpatient beds helped alleviate the burden on Zuckerberg San Francisco General Hospital by providing much-needed bedspace when they were over capacity. Chinese Hospital was able to focus its

limited resources on areas of greatest need and to provide care for the most at-risk patients. Later in the pandemic when COVID cases and deaths were rising, Mr. Tsu donated an additional \$165,000 to purchase two moonbeams – highly specialized devices that disinfect and sterilize hard surfaces creating a safer environment for our patients and healthcare heroes. Mr. Tsu's continued efforts to help Chinese Hospital provide safe spaces for patients and further our mission to provide quality healthcare access to our most vulnerable populations led Chinese Hospital to name him a 2022 Outstanding Community Leader at our 123rd Anniversary Celebration.



KAI MAN LEE OUTSTANDING COMMUNITY LEADER

Mr. Lee has generously supported Chinese Hospital for many years. His latest philanthropic gift was a property in San Francisco valued at \$1.8 million to help fund operations and to lessen the financial impact the hospital experienced as a result of the pandemic. Mr. Lee wished to honor his late wife – Mrs. Lo May Wong Lee – with this generous contribution and dedicated a beautiful panel on Chinese Hospital's 5th floor in her memory. 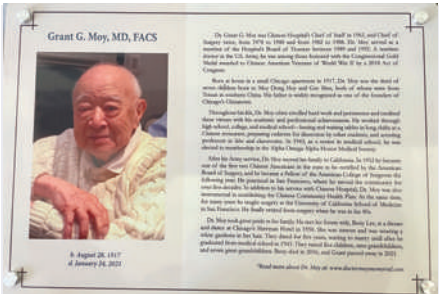

In his memory, Dr. Moy’s family, friends, and colleagues contributed to the naming of the surgical floor staff lounge commemorating his commitment and dedication to our community.

WHEREAS, The Tung Wah Dispensary, Chinese Hospital's previous form, was established in 1899 to provide healthcare services to underserved Chinese community due to blatant discrimination, and language and cultural barriers between American doctors and Chinese immigrants; and

WHEREAS, In response to the growing needs of the Chinese population and the mission to provide a more comprehensive healthcare resources, the Chinese Six Companies – a coalition of 15 community organizations – came together in pursuit of an extensive fundraising campaign to expand its original facility; and

WHEREAS, The modern Chinese Hospital opened its door at 835 Jackson Street on April 18, 1925, making history as the first institution of its kind in the United States; and

WHEREAS, Under the leadership of beloved community leader Rose Pak, who spearheaded the fundraising effort, Chinese Hospital officially opened its newest expansion and celebrated the grand opening of its eight-story Patient Tower in 2016; and

WHEREAS, When the City was hit hard by the global pandemic, which officially began in San Francisco in March 2020, Chinese Hospital was instrumental in the county's response to the global pandemic by serving as the community lead between Department of Public Health and the Chinese community and assisting in keeping the community informed with latest development throughout the pandemic; and

WHEREAS, After over a decade of establishment, Chinese Hospital become a vital pillar of Chinatown and Chinese community, providing essential services and exemplary public health access for residents across the City; now, therefore, be it

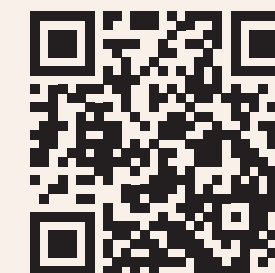
